Department of Public Works implemented the <i>Think Sharp - Safe Syringe Disposal Program</i>.</p> <p>They have registered all seven solid waste disposal facilities as official safe disposal sites for home generated sharps with sharps disposal kiosks/drop boxes.</p> <p>The program not only collects used sharps for proper disposal, but provides the public with proper disposal education and free individual sharps containers at all of their seven solid waste sites.</p> <p>The Public Works Department has partnered with all the local pharmacies (10) who have agreed to help promote the program, advertises the 7 new disposal locations, and also provides residents with free sharps disposal containers (fitpacks and/or 1qt. red sharps containers).</p> <p>All the free sharps containers provided to the public include an attached label and brochure describing the project and the new sharps disposal locations. <p>Brooklyn AIDS Task Force (BATF) 502 Bergen Street Brooklyn, NY 11217</p>	<p>BATF has partnered with 18 pharmacies, and provides them with education and fitpacks.</p> <p>They host two kiosks. One at their 1921-25 Fulton Street Site and the other at their main site, 502 Bergen Street. Syringe disposal hours are: Monday - Friday, from 9 AM to 5 PM.</p> <p>Syringes are furnished through SIBRO at the 502 Bergen Street Site</p> <p>Additionally, in collaboration with BATF an ESAP registered provider furnishes syringes from their mobile van. The ESAP provider works five hours a day, Monday through Friday. Through the agency staff and other agency partners, vouchers are distributed to clients at risk of HIV or are IDUs. The local DOH, State DOH, Stericycle, AIDS Community Service of WNY, The WNY Coalition for Diabetes Prevention and the WNY HIV/AIDS Public Health are working together to promote proper disposal.
